2. COURSE BOOKING AND PAYMENT TERMS

- If you are a student from outside the European Union & Schengen Area, you must undertake to ensure that you have the appropriate visa, which grants you permission to study in Malta. Please note that usually, 6 weeks are required for VISA processing by the embassy or consulate.
- All courses are to be paid in full prior to the course start date.
- Your booking is only confirmed once we have received the cleared funds notification.

We review our pricing annually and any changes will be published & updated immediately. Course prices are inclusive of value added tax however, any bank charges incurred by your preferred method of payment, will be invoiced accordingly.

Payment is deemed to have happened when we have received cleared funds.

3. CANCELLATION POLICIES

We reserve the right to cancel any course, at any time, up to and including the start date of the course. Should this be the case, we will try our best to give you at least, a 14 day notice, as well as the options to either assign for the same course in a future date, or a full refund of your full.

You may cancel your place and ask for a full refund, less any external costs incurred, as long as the cancellation is received in writing at least 30 days before the first day of the course. If you cancel your place 29 days or less, before the start of the course date, then the payment will be lost.

Further you confirm that you consider this to be an appropriate assessment of our loss, including for the avoidance of doubt, lost revenue and lost profit.

Where there are exceptional circumstances these will be dealt with entirely at the school's discretion on a case-by-case basis.

For students requiring a visa to study in Malta, should their visa application, which was made in good faith, be unsuccessful, we will refund the full amount paid, less any external & administrative fees incurred. For the refund the student must present the official document from the embassy or consulate, together with a copy of their visa application, at least 14 days prior to the course start date.

Any applicant found to have made a fraudulent application, including failure to disclose information that may be relevant to their application will not be given a refund.
